Section 1: Opportunity

Our client (Hutchies) required a structural concrete for a large slab. They wanted to maintain normal supply and placement methods to meet project budget and timelines. They were also interested to try out low carbon innovation where possible and viable.

Section 2: Solution

Earth Friendly Concrete by Wagners was a perfect solution. We delivered 310m3 in a continuous pour from a normal batch plant in normal trucks. It was placed normally and exceeded specified strength and curing requirements compared to ordinary concrete.



Section 3: Lessons

Hutchies Site Manager Russell Gillam said, "It is strong, it is durable, it is good for the environment and it can be used to build structures. The slab is in, it's structural and it has achieved its purpose. It's coming up a lot stronger and denser than ordinary concrete".

Section 4 : Impact measurement

Wagners EFC has a Carbon Footprint Declaration that was independently prepared by the Footprint Co.

1m³ of Earth Friendly Concrete contains only 120kg of CO₂, ~70% less than an typical cement based concrete mix.

We eliminated 77.5t of CO₂ in this project, without any offsets.
